



MIAMI BEACH COMMUNITY BIKE RIDE RELEASE AND HOLD HARMLESS AGREEMENT FOR MINORS

The undersigned Releasor represents that he/she is the parent and/or legal guardian of the person of _____, a minor.

The undersigned Releasor, on behalf of himself or herself, and also on behalf of the above-named minor, and their respective personal representative, heirs, next-of-kin and assigns, freely and of his or her own volition, specifically agrees to remise, release, forever discharge and hold the **City of Miami Beach, Florida**, its successors, assigns, servants, employees, elected and appointed officials, and/or volunteers (hereinafter, collectively referred to as the City), and **Miami Beach Bicycle Center, Inc.** and its successors, assigns, servants, employees, directors, officials, and volunteers (the City and Miami Beach Bicycle Center, Inc. hereinafter collectively referred to as "Releasee"), harmless from any and all claims, actions, demands or damages, including but not limited to, accidents, injury, death or damage to the Releasor's person or property, arising or resulting from the Releasor's participation in the Miami Beach Community Bike Ride. The free two-hour bike ride starts at the Miami Beach Bicycle Center, 601 5th Street, Miami Beach Florida, at 9am on the second Saturday of every month. The bike route varies from month to month, but usually covers the entire length of the City.

Releasor, on behalf of himself or herself, and on behalf of the above minor, expressly agrees that this Agreement is intended to be as broad and inclusive as permitted by the laws of the State of Florida and that, if any portion thereof is held invalid, it is agreed that the balance shall, not withstanding, continue in full legal force and affect.

Releasor, on behalf of himself or herself, and on behalf of the above minor, further gives permission for first aid to be rendered, if necessary, and further releases Releasee from any claim whatsoever on account of said first aid, treatment, or services rendered to the child during his/her participation in the aforestated activities/event.

This Release contains the entire agreement between the parties hereto and the terms of this Release are contractual and not a mere recital.

I am aware that cycling is a potentially dangerous activity, involving risk of injury. To further ensure the safety of the aforementioned minor throughout the Miami Beach Community Bike Ride, I will acknowledge and agree to the following responsibilities:

- The minor agrees to wear a helmet, and obey traffic rules and regulations at all times while operating a bicycle during this event.
- The minor is in good physical condition, with no medical impairments that would prohibit involvement in this event.
- I realize these activities/event will include on-bicycle participation, including street and trail rides.

RELEASOR FURTHER STATES THAT HE/SHE HAS CAREFULLY READ THIS AGREEMENT AND UNDERSTANDS ITS CONTENTS AND MEANING AND FULLY REALIZES THAT THE MINOR'S PARTICIPATION IN THE AFORESTATED ACTIVITIES AND EVENT MAY EXPOSE HIM OR HER TO DANGERS AND HAZARDS WHICH MAY ARISE IN CONNECTION WITH THE AFORESTATED ACTIVITIES AND EVENTS, AND HEREBY SIGNS THIS RELEASE ON BEHALF OF SAID MINOR AS HIS/HER OWN FREE AND VOLUNTARY ACT.
