The City of Miami Beach has invested over two million dollars in Federal APD Parking Revenue Control Equipment. In an effort to have consistency in reporting auditing and collection platforms, the City has chosen one system rather than blended systems throughout all of its parking facilities. This equipment is out of warranty (one year) and has been maintained over the last five years by Royce Parking Control Systems, Federal APD sole source service provider. Royce Parking Control Systems, Inc. is the only vendor that may furnish parking revenue control equipment that is compatible with the existing parking revenue control system.
