ITEM 1-APPROVAL OF MINUTES

Elsa Urquiza, Chairperson convened the Personnel Board meeting at 9:10am.

Upon motion of Michael Perlmutter, Associate Member and seconded by David Alschuler, Vice-Chairperson and with all in favor the minutes of the July 20, 2007 Personnel Board meeting were approved.

Newly elected employee member, Paco Basantes representing Group 2, was introduced.

ITEM 2- CLASSIFIED PERFORMANCE EVALUATIONS-THE REQUEST FROM PERSONNEL BOARD MEMBERS FOR DEPARTMENT DIRECTORS WITH MORE THAN 10% OR WITH 10 OR MORE PAST DUE PERFORMANCE EVALUATIONS TO APPEAR BEFORE THE BOARD.

Ramiro Inguanzo went through the list of Departments with 10% or more of their employees that have outstanding performance evaluations and provided an update of the progress these Departments have made since the July 2007 meeting. In addition, Vivian Guzman, Neighborhood Services Director advised the Board that she was working with the Code Compliance Division to complete all past due evaluations within the division.

Ramiro Inguanzo stated that the Human Resources Department would continue to work with all Department Directors to ensure that all performance evaluations are processed in a timely manner.

ITEM 3-REQUEST FOR DISCUSSION OF PERSONNEL RULE VIII-PROBATIONARY PERIOD, SECTION 2 AND TERMINATION PROCESS BY JIMMIE NEWTON

Jimmie Newton, Employee Member inquired about the City's probationary period and termination process. Elsa Urquiza, Chairperson advised Newton that probationary employees are placed on trial within a reasonable amount of time. If the employee is not performing (can not do the job, absenteeism, untimely, doesn't understand the job) within that time, they may be dismissed.


