16. Statute 218.01(5) Notices of meetings and hearings must advise that a record is required to appeal, file a writ, or bring a petition, or agency of this state or of any other state, subdivision thereof, or any other state, or agency, conspicuously on such notice. He advises that, if a person wishes to appeal any decision made by the board, agency, or commission with respect to any matter considered at such meeting or hearing, he or she must, in addition to the proceedings, and that, for such purpose, he or she may need to ensure that a verbatim record of the proceedings is made, which means includes the testimony and evidence upon which the appeal is to be based. The requirements of this section do not apply to the notice provided in s. 200.065(3).
