§6.02(2)(b) Notice of meetings and hearings must advise that a record is required to appear. Each board, commission, or agency of this city or of any public subdivision thereof shall include in the notice of any meeting or hearing, if notice of the meeting or hearing is required, of each board, commission, or agency, respectively on such notice. In which case, if a person decides to appear they shall be available to the board, agency, or commission with respect to any matter considered at such meeting or hearing. If not, they will need a record of the proceedings, and that in such cases, he or she may need to arrange for a suitable record of the proceedings to be made, which record includes the substance and evidence upon which the request is to be based. The requirements of this section do not apply to the notice provided in a 200.02(5)(b).
