File: 286-0105 Notice of meetings and hearings must advise that a record is required to appeal. Each board, commission, or agency of this city or any political subdivision thereof shall include in the notice of any meeting or hearing, if notice of the meeting or hearing is required, of such board, commission, or agency, comprehensive on such notice, the advice that the person desiring to appeal any decision made by the board, agency, or commission with respect to any matter considered at such meeting or hearing, or if she will need a record of the proceeding, and that, for such purpose, he or she may need to secure that a verbatim record of the proceedings is made, which would include the testimony and evidence upon which the appeal is to be heard. The requirements of this section do not apply to the notice provided in 22C.30(2)(f).
