A meeting not noticed in the Weekly Meeting Notice ad and determined to be an emergency meeting will be posted on the bulletin boards throughout City Hall and will be available on the City's website at www.miamibeachfl.gov/news/2/sign/charter.asp or by calling the City Clerk's Office at (305)673-7411.

Fla. Statute 218.01(1) Notice of meetings and hearings must advise that a record is required to appeal. Each board, commission, or agency of this state or of any political subdivision thereof shall advise in the notice of any meeting or hearing, if notice of the meeting or hearing is required of such board, commission, or agency, conspicuously on each notice the notice that, if a person desires to appeal any decision made by the board, agency, or commission with respect to any case considered at such meeting or hearing, he or she will need a record of the proceedings, and that, for such purpose, he or she may need to arrange first to secure a record of the proceedings, a note which record includes the necessary and essential steps which the appeal is to be based. The requirements of this section do not apply to the notice provided to a 229.06(2).
