For Section 256.0105 Notice of meetings and hearings must advise that a record is required to appeal, each board, commission, or agency of this state or of any political subdivision thereof and include in the notice of the meeting or hearing, if notice of the meeting or hearing is required, of each board, commission, or agency, approximately on such notice, the advice that, if a person desires to appeal any decision made by the board, agency, or commission with respect to any matter considered or such meeting or hearing, he or she will have a right of the proceedings, and that, in such purpose, he or she may need to arrange for a witness in order of the proceedings to record, which record includes the summary and evidence upon which the appeal is to be based. The requirements of this section do not apply to the notice provided in 201 0633.
