This Letter to Commission is provided in response to inquiries made during the May 11, 2011 Commission meeting about the Deco Bike program and what preparations they have made for the upcoming Memorial Day Weekend Major Event Plan (MEP). The Administration met with representatives of Deco Bike to develop a plan of action for the anticipated high utilization of the program.

Deco Bike:

- Additional staffing supporting the program for maintenance/relocation of bicycles.
- Monitoring of the utilization of bicycles will be done closely throughout the weekend, and additional bicycles may be strategically relocated or deployed, accordingly.

City:

- Provide temporary, limited storage space for any bicycles, should the need arise.
