Fla. Statute 218.01(5) Notice of meetings and hearings must advise that a record is required. If appeal, if not board, commission, or agency of the state or of any political subdivision thereof shall provide at the notice of any meeting or hearing a notice of the meeting or hearing is required. If such board, commission, or agency, or commission or such notice, the notice shall, if a person desires to appeal any decision made by the board, agency, or commission with respect to any matter considered at such meeting or hearing, advise who will read a record of the proceeding, and that, for such purpose, he or she may need to ensure that a verbatim record of the proceedings is made, which record includes the testimony and evidence upon which the appeal is to be based. The requirements of this section to not apply to the notice provided in a 2008/09/03.
