Form Purpose A Temporary Certificate of Occupancy (TCO) can be issued when a property is still

under construction and minor work is pending. TCOs grant the occupant all of the same rights as a Certificate of Occupancy for a temporary period of time. TCOs are usually effective for 90 days from the date of issue, after which they expire. Prior to expiration,

an occupant can re-apply for a TCO Extension.
