### 2. Review and Approval of November 6, 2013 Meeting Minutes

### 3. 2014 Proposed Committee Meeting Dates

#### 4. Topics of Interest 2014

- Memorial Day Survey for 2014
  - Member William Warren discussed the 2013 Memorial Day survey that was conducted on behalf of the MB Human Rights Committee and had recommended that the Committee move forward with a similar survey during 2014 Memorial Day.
  - Liaison Gomez to obtain copies of the 2013 survey questions and results of the survey and provide to the Committee for the February Subcommittee meeting. Liaison Gomez also to identify the City staff member who assisted the Committee with setup and logistics to provide the survey during Memorial Day Weekend 2013 and see if this individual is able to attend a subcommittee meeting.
  - Discussion was held about the potential of handing out informational cards and/or postcards for the survey, providing an online survey, perhaps utilizing the Goodwill Ambassadors to assist and utilizing various media outlets (i.e. MBTV) to spread the word about the survey.
  - Liaison Gomez to schedule a MB Human Rights Subcommittee meeting for Tuesday, February 11, 2014 at 3:30 p.m.
  
- Elderly
  - Some ideas discussed included: access to services, elderly housing and crimes against the elderly. The Chair recommended that the Committee would need to focus on a specific topic. The Committee agreed to discuss this topic next month.
  
- Intersexuality
  - The Chair recommended that the Committee identify an area that addresses intersexuality since this protected class was just added to the Miami Beach Human Rights Ordinance.
  
- Human Trafficking
  - Member Burttschell advised that there would be a presentation provided on this subject during the February Committee meeting.
  
- Blood Ban
  - Member Burttschell suggested sending a letter signed by 100 (or 50) Mayors from around the Country to the White House and the FDA concerning the blood ban.
  - Liaison Gomez to provide a copy of the resolution and the letter that was sent to Washington, D.C., by the former Mayor and Commission for the February Committee meeting.
  - The Committee will be prepared to redo the resolution urging the Mayor and Commission to send a new letter and the Committee will discuss next steps during the February meeting.

#### 5. Status updated regarding Human Rights Ordinance to include intersex as a protected category.

Committee Chair Fishman advised the Committee that the ordinance amendment to include intersex as a protected category was passed unanimously by the City Commission in December 2013. The City of Miami Beach may be the first municipality to offer this protection. The Chair asked if the LGBT should amend their Committee name to include

intersex (LGBTI). Legal Liaison Rosenwald advised that he would mention this suggestion to the LGBT. The Chair recognized Rob Rosenwald for doing an excellent job on the ordinance.

**6. Status update on the Human Rights brochure publication.**

Committee Liaison Gomez advised that the brochures were revised to include Intersex as a protected category, as well as the creation of a new, simplified website for the Miami Beach Human Rights Committee. The brochures have been printed and are being displayed throughout City Hall and have also been provided to Police for the patrol officers to have available to pass out when appropriate.

**7. Review of appreciation letter for Rafael Granado**

The Committee reviewed the letter and was approved. The Chair signed the letter on behalf of the Committee. Liaison Gomez to provide the final letter to Mr. Granado.

**8. Presentation by Robert Gould, Commission on Women (sponsored by Member Monica Harvey)**

Roberta Gould, Commission on Women Committee Member addressed the Committee and advised that the Commission on Women provides a health fair for the elderly. Ms. Gould spoke about efforts from the Commission on Women's efforts to address domestic abuse. Volunteers from the Commission on Women utilized the Publix on 67<sup>th</sup> Street by placing a table outside on a Sunday from 8:00 am to 6:00 pm and provided informational materials in both, English and Spanish to hand out. Publix maintained leftover materials for their employees in the break rooms. The Human Rights Committee discussed the potential of partnering together with the Commission on Women to continue to address domestic abuse (October 2014 event). Ms. Gould stated that she would provide the Committee with the informational materials for the HRC to disseminate on the City's Human Rights Committee website.

**9. Presentation on Human Trafficking by Janet Anderson, State Attorney Office (sponsored by Member Monica Harvey)**

Item deferred to the February meeting.

**10. Unfinished Business**

- a) "Call to Action" Project – Elizabeth Schwartz, Esq. – Liaison Gomez to reach out to Elizabeth Schwartz, Esq. to determine if she would be willing to continue with this project via a joint committee between the LGBT and the MB Human Rights Committee.
- b) Update on the public service announcements on Miami-Dade Transit Buses – The final proofs of the public service announcements have been circulated for final review and approval. Funding needs to be identified via a discussion with Liaison Gomez and the City Manager. Once identified, Liaison Gomez will reach out to the printing vendor that was already identified by Miami-Dade County.

**11. New Business**

- a) Committee Appointments: Four members are up for reappointment that will be heard at the January 15, 2014 City Commission meeting. They include: Alan B. Fishman, Esq., Walker C. Burttschell, Bradley Ugent and William Warren. The following Committee members' terms expire in December 2014: Monica Harvey, Rachel Ulmas and Rafael Trevino.
- b) The Chair advised the Committee that there was a Commission agenda item being

presented at the January 15, 2014 City Commission meeting concerning abolishing/combining of certain Boards and Committees. Legal Liaison Rob Rosenwald provided the Committee members with a brief overview of the agenda item. In essence, the City currently has a number of Committees that have overlapping functions and also have some Committees who have been inactive for a long period of time. The City Commission will be looking at each of the Committees to determine if they remain, become combined or are abolished. Commissioner Grieco discussed the agenda item and recommended that the Committee members attend the January 15, 2014 Commission meeting to speak on behalf of the MB Human Rights Committee. Committee Liaison Carla M. Gomez will provide a status update to the Committee at the February meeting.

- c) Detective Juan Sanchez advised the Committee that a Standard Operating Procedure (SOP) for the Miami Beach Police Department created to address dealing with transgender individuals. The SOP was created in conjunction with the Center of Equality in Washington, D.C. and is being used as an excellent example for organizations throughout the United States.
- d) Commissioners Malakoff and Commissioner Grieco both attended the meeting separately and said a few words to introduce themselves.

Being no further business, the MBHRC meeting adjourned at 5:27 p.m.

**RESOLUTION OF THE MAYOR AND CITY COMMISSION OF  
THE CITY OF MIAMI BEACH, FLORIDA URGING THE UNITED  
STATES FOOD AND DRUG ADMINISTRATION (FDA) TO  
REPEAL THEIR LONGSTANDING PROHIBITION ON MEN

**WHEREAS**, the United States Food and Drug Administration (FDA) is responsible for protecting the public health; and

**WHEREAS**, the FDA regulates blood donation in the United States and explicitly bars any man who has had sex with another man, at any time since 1977, from donating blood; and

**WHEREAS**, the FDA justifies this policy by citing that 1977 was the beginning of the United States' AIDS epidemic and that men who have sex with men are at a greater risk of HIV, Hepatitis B and other infections that can be transmitted by blood transfusion; and

**WHEREAS**, this lifetime restriction on men who have had sex with men from donating blood fails to consider the individual's HIV status and represents the FDA's policy since 1982; and

**WHEREAS**, in 1982, there were no HIV tests or HIV treatments, and little was known about HIV and AIDS; and

**WHEREAS**, in the more than 30 years since the FDA's decision to exclude men who have sex with men from donating blood, the medical community has made great strides in preventing, diagnosing, treating, and understanding HIV/AIDS; and

**WHEREAS**, the FDA's lifetime restriction on men who have sex with men from donating blood fails to consider the potential donor's actual health status; and

**WHEREAS**, the only other groups on the FDA's lifetime deferral list for blood donation are intravenous drug users, people who have received animal tissue or organs, people who have traveled to or live in certain countries due to the risk of transmitting malaria or variant Creutzfeldt-Jakob Disease (vCJD) and people who have had sex for drugs or money; and

**WHEREAS**, despite the FDA's lifetime ban on men who have sex with men, nationally, an individual needs a life-saving blood transfusion once every 3 seconds; yet, while 60% of Americans are eligible to donate blood, on average less than 5% of people actually donate; and

**WHEREAS**, a single blood donation can save 3 lives, following component separation; and

**WHEREAS**, limiting the population of potential blood donors leaves numerous vulnerable individuals in need of receiving life-saving blood; and

**WHEREAS**, the greater the donor base, the easier it will be to meet the nation's demand for blood, especially when there is a blood shortage; and

**WHEREAS**, Argentina, Australia, Hungary, Japan, New Zealand, South Africa, Sweden and the United Kingdom have all imposed a time period in which men who have sex with men must wait before being allowed to donate, while Russia completely lifted the ban; and

**WHEREAS**, other countries, such as France, Italy, Mexico and Spain screen potential donors for high-risk sexual practices, rather than men who have sex with men behavior, and as such these countries defer all individuals who have engaged in risky sexual behavior; and

**WHEREAS**, the FDA has established a 12-month blood donation deferral period for any individual who has had sexual contact with a person infected with HIV or viral hepatitis, except for men who have had sex with other men; and

**WHEREAS**, the blood donation organizations have jointly recommended that the deferral period for men who have had sex with other men be limited to 12 months since the date of the last such sexual contact; and

**WHEREAS**, there is a constant need for blood, and Miami Beach residents are known to be generous blood donors, and

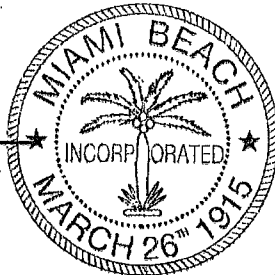

Dear Mr. Granado:

Thank you for forwarding a copy of Miami Beach Resolution 2013-28128, calling upon the United States Food and Drug Administration (FDA) to reverse its policy on blood donor deferral of men who have had sex with other men (MSM). We appreciate your interest in this important matter.

The primary responsibility of FDA is to ensure the safety of blood and blood products for patients who require these products. Our blood donor deferral policies are based on scientific data that demonstrate that certain medical, behavioral, and geographical factors are associated with an increased risk of transfusion transmitted diseases, such as HIV, hepatitis B and C, and variant Creutzfeldt Jakob disease.

We understand that there are different viewpoints on how best to maintain the safety of the blood supply. FDA continues to monitor and evaluate our blood donor deferral policies, including the MSM deferral. Alternative strategies that maintain blood safety may be considered as new scientific data become available.

On June 10-11, 2010, the U.S. Department of Health and Human Services (HHS) Advisory Committee on Blood Safety and Availability (ACBSA) met to discuss the current FDA deferral policy on men having sex with other men (MSM). The ACBSA found that currently available scientific data are inadequate to support a change to a specific alternative policy; therefore, until further evaluation, the committee recommended that the current indefinite deferral for men who have had sex with another man even one time since 1977 not be changed at the present time.


ACBSA heard a wide range of scientific and ethical presentations on this deferral policy at the meeting, and while they recommended retaining the current policy, they were unanimous in finding that the current donor deferral policies, including those directed at MSM donors, are suboptimal, and recommended behavioral and epidemiological studies to support future policy reconsiderations. In response, the Assistant Secretary for Health (ASH) established a working group with representatives from FDA, CDC, CMS, HRSA and NIH to define research pathways that will be responsive to the ACBSA recommendations.




