SUBJECT: Personnel Board Group III Election

Pursuant to Ordinance No. 93-2868 an election was held by the City Clerk's office on July 25 through July 28, 2006, to fill a vacancy on the Personnel Board representing Group III employees. There were a total of 54 votes cast; with 33 votes for Jimmie W. Newton and 21 votes for John Ardila.

Mr. Jimmie W. Newton is elected to represent the Group III members for a term of three (3) years beginning on August 1, 2006 and ending on July 31, 2009.


