



SUBJECT: Personnel Board Group II Election



Pursuant to Ordinance No. 93-2868 an election was held by the City Clerk's office on October 16 through October 19, 2006, to fill a vacancy on the Personnel Board representing Group II employees. There were a total of 36 votes cast; with 9 votes for Dania Granados and 27 votes for Stacy McCrae.

Stacy McCrae has been elected to represent the Group II members to finish the term left vacant by Patricia Becerra, which ends on July 31, 2007.




THAT there were a total of 36 votes cast.
