## LETTER TO COMMISSION

SUBJECT: Personnel Board Group 2 Election

Pursuant to Ordinance No. 93-2868 an election was held by the City Clerk's Office on July 23 through July 26, 2007, to fill a vacancy on the Personnel Board representing Group 2 employees. There were a total of 66 votes cast; with 29 votes for Paco Basantes, 10 votes for Joann Cesar, 15 votes for Stacy McCrae and 12 votes for Rashonda M. Wilson.

Paco Basantes has been elected to represent the Group 2 members for a term of three (3) years beginning on August 1, 2007 and ending on July 31, 2010.

THAT there were a total of 66 votes cast.


