As your community's full-service Digital Video, High-Speed Internet and Phone provider, Atlantic Broadband is committed to keeping you informed about changes to our network, products, services, and prices.

On August 27th, 2007 Atlantic Broadband received notice from Music Choice that it is making some minor changes and enhancements to its national offerings of digital music channels as of September 18th, 2007. Most of these changes/enhancements involve name changes or channel placement changes of their channels. The specific changes are detailed in the attachment included.

Atlantic Broadband has no control over these changes, which are driven by the programmer. Music Choice digital music service is offered as a value added service to our customers that choose to subscribe to a digital receiver(s). Approximately 44% of our Miami area customers subscribe to one or more digital receivers on a monthly basis. Throughout September, Music Choice is announcing their format and name changes on the affected channels.
